Terms of Tender

1. The subject of the present request for quotation/Tender is the procurement of the following supplies:
Supply and delivery of a Gantry machining centre for wood nesting applications and the installation thereof at Grixti Mobili Ltd's factory in Marsa, Malta.
2. The successful bidder(s) shall deliver such supplies at the Factory MRA 027a, Triq Giuseppe Garibaldi, Il-Marsa MRS 9083. Quoted prices shall be deemed to be inclusive of all costs including the **supply, delivery and installation** of the said supplies.
3. The said supplies shall be delivered/installed and commissioned within six months from contract date.
4. The successful bidder(s)/contractor(s) shall be held liable for any losses incurred by Grixti Mobili Ltd. if this deadline is not honoured as well as for any delays in the submission of delivery notes, invoices and/or receipts and due to which Grixti Mobili Ltd. suffers financial liability.
5. This is a unit-price for supplies contracts. Interested parties shall quote for each item separately, with the quote indicating price excluding VAT, the value of the VAT and the price inclusive of VAT **using the tender bidding form provided further below. Its use is mandatory, and bids will be declared not administratively compliant if it is not used.**
6. **All communications shall be made in writing, using the email address in reference.** No other forms of communication shall be entertained.
7. This Tender is being issued under an open procedure.
8. This Tender is NOT **divided into lots**.
9. **All bids must meet the minimum technical specifications provided. Variant solutions cannot be accepted.**
10. The procurement in question forms part of a project part-financed by the SME Growth Grant Scheme, under the Business Enhance Initiative part-financed under Operational Programme I – *Fostering a competitive and sustainable economy to meet our challenges* through the European Regional Development Fund (ERDF) 2014-2020.
11. No clarification meeting/site visit is planned. However, requests for clarifications may be sent by email, as indicated above, by not later than three calendar days from the 'Deadline for receipt of quotations' indicated on the first page of this document. Replies will be published on Grixti Mobili Ltd.'s website within 48 hours from receipt of request for clarification. No clarification will be published later than two calendar days from the 'Deadline for receipt of quotations'.
12. Interested Parties should be aware that upon implementation, (delivery or commissioning whichever is the latest), the Supplier shall issue a delivery note.

Subsequently, the Supplier shall issue an invoice (distinct in form and nature from the delivery note) to request payment. The Invoice should be in line with the VAT legislation, include a description of the goods, reference to contract and delivery.

Together with the Invoice, the Supplier shall fill in the Supplier Financial Identification Form provided by Grixti Mobili Ltd.

In view of the fact that this is a Business Enhance ERDF project, cash disbursements are strictly prohibited. The total expenditure must be paid through transparent, traceable bank transactions, i.e.

either through direct bank transfer or through payments by cheque. Following Payment, the Supplier shall issue a VAT receipt and a warranty.

13. The warranty shall be for a minimum period of **three** years from installation date.
14. Payment terms may include a deposit upon signature of contract.
15. Any quotation submitted under this Tender shall remain **valid for ninety (90) days** from the deadline for the receipt of bids.
16. Interested Parties should keep in view that payments will be made through an identifiable bank account to the identified bank account of the Service Provider/Supplier as outlined in the Supplier Financial Identification Form.
17. In order to be considered eligible for the award of the contract, economic operators must provide evidence that they meet or exceed certain minimum criteria described hereunder.
18. Gixti Mobili Ltd. intends to procure the said supplies from the interested parties submitting the cheapest priced offer satisfying the minimum technical requirements. Bidders shall take the following points into consideration:
 - a) The cost of any operating system/software, including its installation, shall be part included in the price, and not quoted separately.
 - b) Bidders shall ensure that equipment is as environmentally friendly as possible. This shall include, but not be limited to energy consumption, emissions of particulate matter, and noise pollution.
19. Without prejudice to the above Gixti Mobili Ltd. reserves the right to opt in favour of **an offer that is dearer than the cheapest technically compliant offer.**
20. Without prejudice to any other clause in this request for quotations/Tender, Gixti Mobili Ltd. **may for any reason whatsoever, and without any liability whatsoever, cancel the present procurement exercise at any point in time** prior to the signature of contract with the selected bidder(s).
21. The laws of Malta shall apply in all matters relevant to the present Tender and the subsequent Contract to be entered into by Gixti Mobili Ltd. and the Successful Bidder(s).
22. Plans showing the premises where the installation is to take place are attached. Potential bidders shall take cognizance of such plans when formulating their bid.
23. **Eligibility Criteria**
 - i By submitting a quote, a bidder(s) shall be declaring that it does not engage in any form of discrimination on the basis of sex, gender, racial or ethnic origin, religion or belief, disability, age or sexual orientation. It also has policies to safeguarding individuals /employees against victimization and/or harassment.

(i) The Gantry machining centre for wood nesting applications shall meet the following technical specifications, that is it shall:

- have a loading table with automatic label printer on the loading area (label size: 100 x 76 mm)
- have an unloading area with an outfeed belt conveyor including an inbuilt dust collection system on top and bottom of outfeed belt conveyor
- have an auxiliary manual label printer system at the unloading area (label size: 100 x 76 mm) with touch screen size 22" or more;
- have 4 axis (x – y – z – c)
- have a digital device for tool length measurement by contact plate
- have 2 motors for x-axis movement (one in front of the machine and one at the back of the machine)
- have a liquid cooled electrospindle, with a minimum power of 19kW, including a blowing unit with a minimum of four (4) nozzles to increase dust collection efficiency
- have a roller hold-down unit with parking functionality
- have an HSK F63 Aggregate with one outlet, collet coupling or sawblade maximum diameter 180mm, with manual tilting and rotation
- have a working area of at least 3.1m by 2.2m with 16 zones multi-zone vacuum system.
- have 3 x 300m³/hr vacuum pump
- have a tool changer with at least 16 tool positions on board the x-axis carriage
- have an Air conditioner for cooling electrical cabinet
- have an automatic lubrication system
- Boring head with at least 18 vertical spindles, 6 horizontal spindles and 1 saw blade unit for cutting depths up to a maximum of 25mm
- have a 3D CAD CAM design software, including 3D graphic simulator, the ability to calculate processing time and work lists,
- Proprietary software must allow external format inputs
- System must include wireless barcode reader.
- Machine must be prepared for future installation of an automatic unloading system (such as an automatic robot, or any other options available)
- Machine must be prepared for future installation of automatic panel store system.

25. (D) Financial Offer

The Bidder(s) shall provide their submission using the Tendering Bid Form in Annex 1 as a template. They may copy and past it on their letterhead but shall not delete any element from it. Bidders who do not use the attached template, or who delete any element from it, shall be considered not administratively compliant, and their submission not considered any further.
